- Each agency must maintain one master account; account sharing outside your organization is prohibited.
- You are responsible for maintaining the confidentiality of your credentials and all activities under your account.

Tauer reserves the right to suspend or terminate access for any fraudulent, abusive, or unauthorized activity.

### 3 - Subscription Model & Fees

Tauer operates as a subscription-based SaaS platform, not tied to media spend.

#### 3.1 Subscription Structure

- Fees are determined by your selected plan tier (based on number of brands managed and/or data processed).
- Usage thresholds may apply; exceeding them incurs additional fees as specified in your plan.
- All payments are in USD and exclude applicable taxes.

#### 3.2 Billing & Renewals

- Subscriptions renew automatically unless cancelled before the renewal date.
- Payments are non-refundable. Upon cancellation, you retain access until the end of the current billing cycle.

#### 3.3 Modifications

Tauer may update pricing or plan features with prior notice sent to your registered email or account dashboard.

#### 4 - Use of the Platform

You agree to use Tauer solely for lawful business purposes related to media operations. You may not:

- Upload or distribute malicious code, viruses, or automated bots.
- Reverse engineer, resell, or copy Tauer's software.

## 5 - Partner Agency Framework

- Agencies may not repackage or resell Tauer's technology as standalone software.
- Tauer may use anonymized and aggregated data to improve its AI systems and services.

We collect:

- Account and user details (agency name, contacts, billing info).
- Campaign performance metrics, creative data, and audience insights.

We comply with data privacy regulations including **GDPR**, **LGPD**, **and Habeas Data**. Full details are in our Privacy Policy, incorporated herein by reference.

- Tauer provides its services "as-is" and "as available."

#### 9 - Termination & Suspension

Tauer may suspend or terminate access if:

- Fees remain unpaid after the due date.
- You engage in illegal, abusive, or unauthorized activities.
- You breach these Terms.

#### Upon termination:

- Your account data may be retained for 30 days, after which it may be deleted.
- You remain responsible for any outstanding payments.
- You may request data export before deletion.

### 10 - Limitation of Liability

To the maximum extent permitted by law:

- Tauer's total liability is limited to the amount paid by you in the previous 12 months.
- Tauer is not liable for any indirect, incidental, or consequential damages, including loss of profit, data, or goodwill.
